

"Hello, Mr. Bob." Frank Mallon's 2006 phone call to me began casually, much like his first call in the 1990's when he recruited me to serve as Detroit Area Council's Michigami District Chairman. But this time a different tone emerged. Frank's voice had a strong undercurrent of excitement and a sense that a new adventure was about to begin...an adventure that would be fun, historic and rewarding. And with his engaging style, he was inviting me to be part of it.

As I soon learned, the adventure had begun months before with a free-wheeling discussion among Frank and a few of his close adult Scouter friends. They brainstormed ways to celebrate the Boy Scouts of America 100th Anniversary in 2010. The celebration had to be unique, memorable and a tribute to Boy Scouting's history and the values the program, its leaders and its volunteers had instilled in millions of boys over those 100 years.

A map, a mural, a title, and an organization emerged from that discussion. Sixteen volunteer teams would crisscross the continental United States from February 2009 to February 2010 visiting each of the 300 Boy Scout Councils, presenting its adults and boys with an original mural depicting famous Scouts and symbols representing Scouting's values. This would be "The Century of Values Road Journey." And I was being recruited to help publicize it in small towns and large cities across the entire country.

This book is about the "The Century of Values Road Journey" and the 130 men and women, young and old, who made it a reality. It's been 10 years since the last mile was put on the RV, the last mural presented and the last patch sold. But the stories continue as photos are brought out and shared. This book introduces some of those stories and photos for the first time.

Frank Mallon gave me the opportunity to enjoy publicizing what "The Century of Values" road teams were going to do. With this book, you can enjoy what they actually did.

Our 32-foot recreational vehicle donated by All American Homes/Coachmen, was driven by sixteen different road teams of adult volunteer Scouters from southeast Michigan. These teams drove the Recreational Vehicle 49,000 miles throughout the United States of America from February 7, 2009, to February 8, 2010, in an adventure called "A Century of Values" celebrating 100 years of Boy Scouting traditions and values.

An additional 8,000 miles were logged as we took several "Victory Laps" around the state of Michigan and to several councils outside the state. We participated in local parades, council camporees and other special events.

The rear of the motorhome displays our centennial mural of Scouting's history that was presented as a "Thank You" to the Scouts, Scouters and families to over three hundred Boy Scout councils throughout the United States of America.

The colorful wrap on the front and sides of the vehicle, beautifully shows the Scout Oath, Scout Law, all the past and present Boy Scout books, our ACOV patch and a huge United States map showing our travel routes and council stops. Many other Scout symbols and icons are displayed as well as the logos of our major sponsors of the year long journey.

Bill Morrison is best known for his work with The Simpsons and Futurama and Creative Director, writer and artist at Matt Groening's Bongo Comics.

He began his career as an illustrator, painting dozens of movie posters including many for Walt Disney pictures, such as The Little Mermaid, Bambi, Peter Pan, Cinderella and The Jungle Book.

When Bongo Comics was founded, Bill was on board as art director and drew the very first Simpsons comic book. He soon took on the role of Creative Director, writing and drawing stories and covers and editing Bongo's entire output.

In addition to his Bongo work, Bill has created thousands of Simpsons and Futurama drawings for T-shirts, video games, posters, toy packaging, books, calendars and limited-edition prints.

Bill worked on early character designs for the Futurama TV series and served as series Art Director. He recently worked as character designer and artist on the Netflix series, Disenchantment.

Morrison also created a graphic novel adaptation of The Beatles' Yellow Submarine for Titan Comics and was Executive Editor of MAD Magazine.


January 22, 2010 - Philmont Scout Ranch (Team 14A)




February 23, 2009 - Hot Springs, Arkansas (Ouachita Area Council)

Day 18 on the road. We started the day off early with a 30-minute interview on 1340 AM radio talk show.


March 6, 2009 - San Antonia, Texas (Alamo Area Council)

Mark Ryan, Assistant Director of Field Services, accepted the mural on behalf of the Cradle of Liberty Council and thanked the entire ACOV staff of volunteers for their hard work and efforts in reminding about the accomplishments and values of Scouting.




INTERESTING FACTS #7A

The McKenzie Statue

(The Ideal Scout/aka: The Boy Scout)

Sculptor Dr. Robert Tait McKenzie (1867-1938) was a personal friend of Lord Baden Powell. Dr. McKenzie sat on the executive board of the Boy Scout Council in Philadelphia for more than 20 years. He was the only artist to take part in five Olympic art competitions, winning a bronze medal in 1932. The IDEAL SCOUT was his most famous work. This life-size statue stood six feet tall and was presented to the Cradle of Liberty Council in 1937. The original of the statue was created in 1914 as an 18" desktop statuette.

Dr. McKenzie said that the boy's uncovered head denoted reverence, obedience to authority and discipline. The hatchet held by the Scout is a symbol of truthfulness and the hope it would never be unsheathed for wanton destruction.














